NOTICE

You MUST respond to this citation on or before your arraignment date. You MUST appear in court if you were issued a CRIMINAL violation. Failure to appear for a Criminal violation may result in the issuance of a warrant for your arrest. You MUST appear in court if your complaint was issued because of an accident involving death or injury. You MUST appear in court unless you choose one of the options on the following page.

OPTION #1

DEFENSIVE DRIVING PROGRAM

Attending Defensive Driving School provides the opportunity to have on eligible charge dismissed without going to court and points assessed for that charge. If you receive an extension for attending school, that extension is only for the eligible charge. You must appear in court or pay the fine(s) for any additional charges(s) on your citation on or before the time indicated on your citation.

You are eligible to attend D.D.S. if you meet all the following requirements:

1. You have **not** attended a D.D.S. for an AZ violation within the last 12 months prior to the date of your current violation.
2. Your traffic charge did not result from an accident involving death or serious physical injury.
3. Your case has **not** been set for hearing.
4. You were not driving a vehicle that requires a commercial license (A.R.S. §28-3392).

Effective 08/31/2019 those drivers have a commercial driver license and driving your privately-owned vehicle may be eligible to attend.

WHAT TO DO:

1. If you wish to attend a class in Arizona, in another state or via online, you may do so by contacting on of the Arizona Supreme Court certified schools.
2. To find a certified school:
 - a. Visit <http://www.azcourts.gov/drive>
 - b. Call the Defensive Driving School information line at 1-888-334-5565
3. **You must complete the class SEVEN days BEFORE your court date** for citation dismissal (no conviction will appear on your driving record). The school will verify your eligibility, provide you with further instructions, and report your completion to the Court.
4. If you need more time to complete the class, a motion to the court stating the reason for an extension is required. You may also appear in person to request an extension.

REQUEST A HEARING

READ AND SIGN the following statement:

() *I hereby request a hearing to contest the charges indicated below I am entering a plea of not responsible. I understand that I am forfeiting the option of attending a Defensive Driving Course for those charges for which I have requested a hearing. I understand that I may voluntarily enclose a bond (certified funds only, no personal checks) equal to the fines plus the court improvement fee, which will be forfeited should I fail to appear for my hearing. I further understand that the bond forfeiture will relieve me of the possibility of the court assessing additional monetary sanctions should I fail to appear.*

INFORMATION

ARS §28-907A – CHILD PASSENGER RESTRAINT
Provide a receipt proving purchase of child passenger restraint system after the date and time the complaint was issued and the fine may be reduced to \$0.00.

ARS §28-2532A – NO PROOF OF CURRENT REGISTRATION - Provide proof of current AZ plate or registration and we shall dismiss the charge.

ARS §28-3169A – NO DRIVER LICENSE IN POSSESSION - Provide a valid driver license on the date and time the complaint was issued, and the charge will be dismissed.

ARS §28-4135B and ARS §28-4135C – NO PROOF OF FINANCIAL RESPONSIBILITY (INSURANCE) – Provide proof of insurance showing that the vehicle involved was insured ON THE DATE AND TIME THE COMPLAINT WAS ISSUED and per ARS §28-4135D, court SHALL dismiss the charge with proof that insurance was in effect on DOV or if defendant had policy that covered defendant and any vehicle he or she was driving. *IF there was NO INSURANCE in effect on the date and time the complaint was issued, you MUST appear in court.*

TO AVOID PAYING THE MANDATORY CIVIL PENALTY OR RECEIVE A SUPENDED DRIVER LICENSE, REGISTRATION AND LICENSE PLATES FOR 3 MONTHS, YOU MUST BRING WITH YOU TO COURT:

1. Proof of purchase of a six-month policy that meets requirements of ARS §28-4009.
- AND
2. A copy of MVD driving record showing you had no insurance violations within the past 24 months or not more than one violation within past 36 months.

DRIVING ON SUSPENDED, REVOKED OR CANCELLED LICENSE

ARS §28-3473A or ARS 28-3480A (CRIMINAL CHARGE)
YOU MUST APPEAR IN COURT

ARS §28-3482 (CIVIL CHARGE) The court may dismiss the charge with proof that the person’s unrestricted privilege to drive has been reinstated. This includes a driving history from MVD AND proof of reinstatement.
